



## **The Nest by Oleander Farms Pet Policy**

**Welcome to The Nest by Oleander Farms, Karjat. We are thrilled to be a pet-friendly resort and want to make your and your pet's stay as comfortable and enjoyable as possible. To ensure the safety and comfort of all our guests, please review and adhere to our pet policy:**

### **1.General Rules**

- Pets are welcome in designated pet-friendly rooms only. (Garden View Rooms)
- Please inform the front desk at the time of booking if you will be bringing a pet.
- There is a maximum of two pets allowed per room.
- Only domesticated animals (e.g., dogs and cats) are allowed. Other animals must be approved by management.

### **2.Pet Fees and Deposits**

- A non-refundable pet fee of 1000+Taxes per pet, per night, will be charged.

### **3.Health and Safety Requirements**

- Pets must be up to date on vaccinations. Proof of vaccination to be submitted at check-in.
- Pets must be free of fleas, ticks, and other parasites.

### **4.Supervision and Control**

- Pets must be on a leash or in a carrier in all areas of the resort.
- Pets should not be left unattended in guest rooms unless they are crated. If pets are left alone and create disturbances, guests may be asked to return to the room.
- Pet owners are responsible for controlling their pet's behaviour. Aggressive or disruptive pets may be asked to leave.

### **5.Pet-Friendly Areas**

- Designated pet-friendly areas are available for pets to play and relieve themselves. Please use these areas only. (The Nest Meadow)
- Pets are not allowed in the following areas: The Nest Kitchen, indoor area (GameZone), pool areas.

### **6.Waste Disposal**

- Guests are responsible for cleaning up after their pets. Waste bags to be carried by the pet owners in pet-friendly areas, and to be disposed in dedicated disposal area.

- A cleaning fee may apply if waste is found in undesignated areas.

### **7.Noise and Disturbances**

- Please be mindful of noise. Excessive barking or disruptive behavior may result in additional fees or removal of the pet from the property.
- Guests should take their pets for walks or other activities to reduce disturbances.

### **8.Damages and Liabilities**

- Guests are responsible for any damage caused by their pets, including repair or replacement costs for furniture, carpets, linens, and other items.
- The resort is not liable for any pet-related injuries or accidents involving pets or other guests.
- If your pet bites, injures, or causes harm to another pet, guest, or staff member, you, as the pet owner, assume full responsibility for all consequences arising from the incident. This includes, but is not limited to, all medical expenses, veterinary costs, compensation, and any additional expenses incurred because of the injury or harm caused by your pet.

### **9.Health and Hygiene Protocols**

- Please refrain from bathing pets in the bathroom facilities provided for guests.

5. I agree to pay any additional cleaning fees if my pet(s) create excessive mess or noise that disturbs other guests.
6. I acknowledge that Oleander Farm is not liable for any injuries or accidents involving my pet(s) or other guests.
